



New Patient Visits now only \$99. Children (<18yo) are \$49 to get started. Includes limited treatment plan and usually involves recommended labs. Lab follow up review is \$59 or \$0 if membership is started.

Well Life loves bioidentical hormone replacement patients. We have found that treating someone with hormone replacement alone can be very narrow sighted and doesn't account for the complexities of the human body. Membership is required, but pellet insertion cost is very competitive at only \$150 + the cost of the pellets. We don't mark up our pellet cost!
